Subject: तरवे नमः- Mission Green Schools

Our environment is the greatest gift of Mother Nature to us. A clean environment is vital to have a peaceful and healthy life. But because of some negligence of human beings we have put our nature in a dangerous threshold. In order to make the generations to come more sensitive and concerned about their environment and to reinforce positive attitude and values towards preserving it, CBSE proposes to plant trees and celebrate 'Prakriti Mahotsav' "तरवे नमः" in all the schools affiliated to it from **13th August to 17th August 2018**. The broad guidelines for the celebration of the Mahotsav are as under:

1. Plantation may be taken up during the period from 13th to 17th August 2018 in the school premises.
2. Each school will plant 11 trees of native species appropriate to be nurtured in the area where the school is situated. Each tree may be given a unique name of a martyr for proper identification and personal touch.
3. Schools will upload the following information on the CBSE website:
 - a. Picture of Plant
 - b. Name of Plant Species
 - c. Height in cm.
 - d. Date of Plantation
 - e. Name Given to it

4. Students may be given the responsibility of planting and observing trees for their growth as part of activities conducted under Eco-club already established in most of the schools.

We are sure that this initiative of CBSE with its affiliated schools (20709 as on date) will result in plantation of 2,27,799 trees to protect the earth. This will be a contribution of CBSE family to protect the environment and our future generations.

All schools are requested to celebrate 'Prakriti Mahotsav' enthusiastically and make the campaign **Mission Green Schools** a success.
