Subject: Sensitization regarding challenging and satisfying career.

Dear Principal,

Central Board of Secondary Education offers a compulsory subject called 'General Foundation Course' for all the students in classes XI and XII. The 'General Foundation Course' aims to promote the awareness of students regarding current affairs and general knowledge including prospective future career options. You may be aware that two periods per week have been earmarked for this compulsory subject.

It has been decided by the Board that all the schools affiliated to it, must provide guidance to students in senior secondary classes about prospective career options. It has also been emphasized that in addition to other possible career options, the schools must also expose students to challenging and satisfying career in the Armed Forces under 'General Foundation Course'. The schools may visit the official websites of Indian Army (http://indianarmy.nic.in), Indian Air force (http://www.careerairforce.nic.in) and Indian Navy (http://nausena-bharti.nic.in/) for the motivational material in this regard.

The NCERT has also published a supplementary book titled 'The Indian Army-A Glorious Heritage'. The book contains motivational cum informative write-up for students of different age groups. The supplementary book is eve catching with a view to attract young students to serve in Armed Forces as a career option.

This would help to inculcate a Defence services work ethos which is characterized by diligence, perseverance, dedication, a regimented way of life and above all resilience and humility.
