

Subject: Change in Syllabus in Kannada and Telugu Class IX-2013-14.

Dear Principal,

As you are aware, the CBSE follows the textbooks developed by the State in most regional languages and sometimes these changed textbooks are brought to the notice of the CBSE only in mid-session. Thus in continuation with the notification no.40/August regarding textbooks for class IX in the subjects of Kannada and Telugu, the schools concerned are directed again that the question paper based on either the old or new text book/s,(whichever the school is following) may be made available to students for class IX, SA-I and SA-II for the current session.

The change in the syllabus as per the new textbook and the old syllabus are available at annexure 'A'. It may be noted here that the changes in syllabus are only in SECTION D (Literature from the textbook). No other change in any of the other sections has been made for the current session.

You are requested to take a note of the above change and bring it to the notice of all the teachers and students concerned.
