Subject: **Revised guidelines for Practical Examination in Physics, Chemistry and Biology for Visually Impaired Students of classes XI and XII**

Dear Principal

The Central Board of Secondary Education had issued guidelines for Practical Examination in Physics, Chemistry and Biology for Visually impaired students for class XI through circular No.91 dated 23<sup>rd</sup> December,2011. These guidelines have now been revised further and made more broad based and comprehensive. It includes general instructions, list of apparatus and items for identification, list of practicals (experiential manner rather than recording observations), sample questions and assessment scheme for classes XI and XII (See Annexure). The revised scheme is effective from March,2015 examination for both the classes.

It is further clarified that the revised scheme for Visually impaired students is being extended only to CBSE affiliated schools. The schools, the parents, the students and other stakeholders may carefully refer to the requirement of admitting organisations/colleges/universities for further upward mobility in the academic career related to these subjects.
