Subject: Conduct of Summative Assessment (SA-II) for classes IX and X for schools offering Vocational subject/s (compulsory or optional).

Dear Principal,

This is pertaining to the conduct of Examination under Summative Assessment (SA-II) for classes IX and X to be held in March 2015 in schools affiliated to CBSE. The following may please be noted for Schools offering Vocational subject/s (compulsory or optional).

Vocational as Compulsory Subject:

The schools which are offering Vocational subject/s as Compulsory 6th subject in classes IX & X and following the Rationalized Curriculum of the Academic subjects will receive question papers for both Board Based and School Based Examinations.

1. **Board Based Examination:** The schools that have opted for Board Based Exams would get the Board Papers and the students would appear for the examination at the allotted centres.
2. **School Based Examination:** The Schools would be receiving the question papers and marking schemes for both Academic and Vocational subjects through emails.

Vocational as Optional Subject:

The schools which are offering Vocational subject as optional 6th subject are requested to download the question papers of Academic subjects from *CBSE-Integrated Test Management System (CBSE-ITMS)* and question papers of Vocational subjects will be sent through email from the Vocational Unit.

The Central Board of Secondary Education is currently offering various skill based courses at secondary and senior secondary levels to impart knowledge and training that strengthens the core skills of the students. To give impetus to this programme the Ministry of Human Resource Development (MHRD) has launched the National Vocational Education Qualification Framework (NVEQF)/now known as NSQF from Class IX onwards, to be implemented in educational systems throughout schools, colleges, polytechnics and universities from 2012-13. The following programmes under various domains have been identified by CBSE for implementation in schools starting from Level I i.e. from class IX onwards from the Session 2012-2013:

- i. Retail (code 401/461)
- ii. Security (code 403/463)
- iii. Information Technology (Code402/462)
- iv. Automobile Technology (code 404/464)
- v. Travel & Tourism (code 406/466)

All these courses may be offered as compulsory or optional.

Practical Assessments:

The Practical Assessments for Vocational subjects under NSQF should be carried out internally by the respective schools.

In case of Joint Certification, the respective Sector Skill Council will carry out the Practical Assessments and the details and timeline will be communicated in due course.

Therefore, it is requested to provide the **registered e-mail ID** wherein the Board can send question papers and marking schemes.

It is also requested to provide **an alternative e-mail ID too** for sending the password.
