**Subject: Commemoration of International Day against Violence and Bullying (including Cyber Bullying) at School on 5<sup>th</sup> November 2020 – regarding**

### Background

As you are aware, incidents in some schools across the country have highlighted the need for a safe and secure learning environment for all children. Violence in schools has severe consequences in learners' lives, ranging from low self-esteem and depression, with many students avoiding school, achieving below their potential, or dropping out completely. So the issue of school bullying – the most prevalent form of violence in schools, which affects almost one in three learners, and impacts education and wellbeing outcomes requires immediate attention.

### Commemoration of International Day against Violence and Bullying

In light of the above, UNESCO is commemorating **International Day against violence and bullying (including cyber bullying) at school** on **5<sup>th</sup> November 2020** under the theme '**Together against Bullying in school**'.

### Aims

- To build global momentum to end bullying in schools by raising awareness of the issue.
- To share ways to address and eliminate violence in schools.
- To mobilise governments, experts and the educational community to come and work together in preventing violence and bullying in schools.

### Action to be taken by Schools

School Heads are encouraged to join hands with UNESCO New Delhi in observing this International Day and ensure safe and secure learning environment for all students.
