As you are aware November 26 is celebrated as Constitution Day to commemorate the adoption of the Constitution of India. As part of the celebrations, a number of activities aimed at highlighting and reiterating the values and principles enshrined in the Constitution are being organised.

An important part of the celebrations is the reading of the Preamble to the Constitution and reaffirming our commitment to uphold its ideology. **This year, the Hon'ble Prime Minister will lead the reading of the Preamble at 11 A.M. on 26**<sup>th</sup> **November 2020** during the Conference of the All India Presiding Officers at Kevadia, Gujarat.

All the School Heads are requested to encourage their students and teachers to join the Hon'ble Prime Minister in reading of the Preamble at 11 A.M. on 26<sup>th</sup> November 2020 from their respective locations. A copy of the Preamble is enclosed for ready reference. Other activities like Talks/Webinars on constitutional values and fundamental principles of the Indian Constitution may also be organised. While doing so it may be ensured that guidelines issued in the wake of COVID 19 pandemic are adhered to.

# THE CONSTITUTION OF INDIA

WE, THE PEOPLE OF INDIA, having solemnly Preamble, resolved to constitute India into a <sup>1</sup>[SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC] and to secure to all its citizens:

JUSTICE, social, economic and political;

LIBERTY of thought, expression, belief, faith and worship;

EQUALITY of status and of opportunity;

and to promote among them all

FRATERNITY assuring the dignity of the individual and the <sup>2</sup>[unity and integrity of the Nation];

IN OUR CONSTITUENT ASSEMBLY this twentysixth day of November, 1949, do HEREBY ADOPT, ENACT AND GIVE TO OURSELVES THIS CONSTITUTION.
