Green Skills are the building blocks of this green transition and the key to unlocking the human capital that will power it. We need to ensure green skills are hardwired into the skillset of future generations. Green-skilling is needed to fuel greener jobs. Mission: The mission of this Sustainability Accelerator is to:


- ❖ encourage students to be valuable contributors to climate change/action

Program Format:

- ♣ Duration: 12-day internship
(7 days virtual + 5 days on a corporate campus for top 100 students)
- ♣ Target Audience: 14–22-years (grades 8 and above)
- ♣ Virtual Format:
 - 23 January 2023 to 4 February 2023
 - 6 Learning Days and 6 Mission Days and a final Industry Day
 - Learning Days – 2-hour Instructor Led Live webinar
 - Mission Days - self-paced learnings and working on mission activities (no instructor led sessions on mission days)
 - Students to participate in missions after each day's session on the online platform (Flaunch) for students to participate in challenges, submit assignments, develop new skills through mission-based challenges and win exciting rewards.
 - Students will need to complete missions and acquire points to move forward
 - There will be a checkpoint after Day 2, Day 4 & Day 6 to decide who moves forward
 - Top 10 students will be selected for 5 days workplace experiences and project work with industry partner, Aditya Birla Fashion and Retail Limited (ABFRL).
