The goal of a well-designed school curriculum is that it exposes children to maximum skills and knowledge to make them better informed and productive member of the society. According to NEP 2020, **by 2025, at least 50% of learners shall have vocational exposure through school and higher education.** Every child is supposed to learn at least one vocation and be exposed to several more. The NEP 2020 stated that there will be 'no hard separation' between the 'vocational and academic streams.
