In alignment with the National Education Policy (NEP) 2020, which envisions the integration of vocational education from Grade 6 onwards. The policy aspires that by 2025, at least 50% of learners will have access to vocational education, emphasizing experiential learning over rote memorization.

In this regard, it is informed that NCERT has developed activity cum textbooks (Link: https://ncert.nic.in/textbook.php?fekb1=0-6) named as Kaushal Bodh as an experiential learning framework to support the integration of Vocational Education, Art Education and Physical Education into school curricula, particularly in alignment with the NEP 2020 and NCFSE 2023 from grade 6 onwards. It provides structured guidance for implementing skill-based projects and activities in Grades 6 to 8, aiming to connect classroom learning with the world of work. Further, NCERT textbooks are also available for the new curricular areas - Art Education and Physical Education.
