Subject: Stamp Design Competition on the Occasion of UN@80-reg.

Dear Principal,

The United Nations will be celebrating its 80th anniversary in October 2025. As part of the commemorative events for **UN@80**, the **Department of Posts**, Ministry of Communications, Government of India, in collaboration with the **Ministry of External Affairs**, is organizing a **Stamp Design Competition** for school students on the theme:

"UN@80 and India's leadership in building our future through multilateralism, global leadership, and stewardship."

The competition will be held from **8th July 2025 to 15th August 2025** through the **MyGov portal**. The winning design at the national level will be issued as a **postage stamp** and released at a national event on **24th October 2025**.

Eligibility:

- Students of **Classes IX to XII** are eligible to participate.
- The artwork should be made on **A4 size (200 GSM) white art paper**, using crayons, pencil colours, water colours, or acrylic paints.

Guidelines:

1. Each school should organize the competition between **8th July and 15th August 2025** at their level.
2. Schools are to **screen the entries and select up to 05 best designs**.
3. These shortlisted designs must **be scanned and uploaded by the school on the MyGov portal** within the stipulated time.
4. A committee chaired by the Chief Postmaster General (CPMG) will evaluate submissions for national selection.

Action Points for Schools:

- Organize the competition and encourage maximum participation.
- Nominate a School Nodal Officer for coordination and uploading entries.
- Ensure that the selected designs align with the theme and submission specifications.

Schools affiliated to CBSE are urged to actively participate in this creative initiative that celebrates India's global leadership and commitment to multilateralism through student expression.
