Schools shall continue to be assessed across the six thematic areas of Water, Toilets, Handwashing with Soap, Operation & Maintenance, Behaviour Change & Capacity Building, and Mission LiFE Activities.

- Ensure timely registration of the school on the SHVR Portal/Mobile Application.
- Complete the self-assessment process within the timelines prescribed.
- Nominate appropriate staff members to coordinate the SHVR activities and maintain the required records and evidence.
- Encourage active participation of students, teachers and the school community in promoting cleanliness, sustainability and environmentally responsible practices.
- Participate in the orientation and capacity-building programmes conducted by NCERT and other designated authorities.

ABOUT SWACHH EVAM HARIT VIDYALAYA RATING (SHVR) 2026-27

Swachh Evam Harit Vidyalaya Rating (SHVR) 2026-27 empowers schools to assess themselves under six key categories- Water, Toilets, Handwashing with Soap, Operation & Maintenance, Behaviour Change & Capacity Building and Mission LiFE activities and be recognized at District, State, and National levels.



KEY HIGHLIGHTS

- SHVR aligns with National Education Policy 2020 promoting citizenship skills, values and environmental awareness.
- Six key packages – Toilet, Handwashing with Soap, Water, Operation and Maintenance, Behaviour Change and Capacity Building, Mission LIFE Activities.
- Effective functioning using ICT tools, behaviour change communication, innovative financing and partnerships.
- SHVR-based situation analysis helps identify infrastructure and service gaps and supports school level Swachhata Action Plan (SSAP) under Samagra Shiksha.
- Key stakeholders include Rural/Urban Local Bodies, Government Agencies (Districts and States/UTs) and Civil Society Organizations.
- SVP 2021-22: Participation of approx. 8.23 lakh schools from all States & UTs. The initiative was upgraded to SHVR in 2025-26, and the next cycle, SHVR 2026-27, is now being rolled out nationwide.
- SHVR is applicable to Government, Government Aided and Private Schools from both Rural and Urban areas.

OBJECTIVES

- Promoting Cleanliness**
Ensure clean and well-maintained schools premises through proper sanitation, regular cleaning, and effective waste disposal systems.
- Hygiene Education**
Educate students on personal hygiene and public health practices like handwashing, dental care, and cleanliness.

Promote environmental sustainability with green practices such as rainwater harvesting, recycling, renewable energy, and developing green spaces.
- Involvement of Community**
