Extension of the last date to register for the 'Innovation Ambassador Program'

This is with reference to CBSE Notification No. 40/2021 dated 04.05.2021 and CBSE Notification No. 41/2021 dated 10.05.2021 regarding the Innovation Ambassador Program – An online training program for teachers by CBSE in collaboration with Ministry of Education's Innovation Cell (MIC) and AICTE.

In view of the current pandemic situation and the requests received from many schools, the Competent Authority has agreed to extend the last date for registering the teachers for the online 'Innovation Ambassador Program' **from 17th May 2021 to 25th May 2021**.

The schools who have already registered their teachers need not register again.
