
#### Launch of School Innovation Councils

'School Innovation Council' is a novel initiative to systematically handhold schools in establishing ideation, innovation, and entrepreneurial ecosystem in a sustainable manner. This initiative will be launched on 1<sup>st</sup> July 2022 at 2:30 P.M. by the Hon'ble Secretary, Department of School Education, MoE, the Chairperson, Central Board of Secondary Education, and the Chairman, All India Council for Technical Education.

All CBSE schools are advised to establish School Innovation Councils as per the guidelines given on the SIC website (<https://sic.mic.gov.in>) and the CBSE website [cbseacademic.nic.in](http://cbseacademic.nic.in). Schools that have already registered for the School Innovation Ambassador Training Program (SIATP) are automatically registered on the SIC portal. These schools have to log in to the SIC portal using the same credentials and fill in all additional details to request approval from its council. Registrations will be open from 1<sup>st</sup> July 2022 onwards.
