Capacity Building Sessions & Cyber Safety Awareness activities under the Digital Citizenship (Digital Nagrik) Programme – 2025

As part of its continued commitment to fostering responsible and safe digital practices among students and educators, the Central Board of Secondary Education (CBSE) is pleased to launch the **Digital Citizenship (Digital Nagrik) Programme – 2025**. Under this initiative, a series of Capacity Building Sessions and School Level Activities have been scheduled with support of Meta India through its implementation partner organisation, 1M1B. This series of engagements is aimed to equip students and teachers with essential cyber safety skills, promote ethical digital behaviour, and foster critical thinking in the digital age.

Details of the engagements as part of the Digital Citizenship (Digital Nagrik) Programme-2025 are as follows:

1. Virtual Capacity Building Sessions for Educators:

Four virtual Capacity Building sessions will be conducted for educators. Each session will include a brief interaction with an industry expert from the cyber safety domain, followed by a focused training module designed to equip teachers with lessons they can effectively deliver in their classrooms. 2. Activities for Cyber Security/ Digital Safety Awareness:
