Exposure Visit of CBSE School Principals to Organizations/ Institutions of Eminence in India

The National Education Policy (NEP) 2020 emphasizes that Skill Education must form an integral part of School and Higher Education. In alignment with this vision, the Central Board of Secondary Education (CBSE) has undertaken initiatives to promote Skill Education from Class VI onwards in all its affiliated schools.

To strengthen this initiative, the Board is organizing a series of Exposure Visits to various organizations and higher education institutions of eminence across India. These visits aim to provide school leaders with firsthand exposure to leading institutions so that they may explore future collaborations for integrating Skill (Vocational) Education into mainstream education and effectively utilize institutional infrastructure in a time-shift manner.

The primary objective of these exposure visits is to orient school principals on various skill-based subjects and familiarize them with innovative models, practices, and learning environments. These visits are designed to create interactive learning spaces, offer insight into diverse educational ecosystems, and build awareness of the latest trends and best practices in Skill (Vocational) Education.

- The Central Board of Secondary Education (CBSE) will reimburse a maximum of ₹10,000/- (Rupees Ten Thousand only) as TA/DA or actual TA/DA, whichever is less, on the production of certified hard copies of original bills, for both Government School Principals and Principals of Private Independent Schools.
- Principals who have not attended any previous exposure visit may register for participation.
- TA/DA reimbursement will be limited to one exposure visit per principal in an academic year.
- As seats are limited, interested principals are advised to fill the registration form only if they are confident of participating in the exposure visit.
- If unable to attend after registration, please inform the Board at least one week before the commencement of the visit by sending an email to skedu-77@cbseashiksha.in, so that the slot can be offered to another eligible participant.
- An email confirmation will be sent to selected participants well in advance. Only those who receive the confirmation email will be permitted to attend the exposure visit.
- After completion of the exposure visit, participants are required to submit the TA/DA bills along with relevant supporting documents within 10 days from the date of conclusion of the visit.
- Bills received after one month from the date of conclusion shall not be entertained under any circumstances.
- PI submit a hard copy (ONLY) of certified copy of original bills addressed to : The Director, Department of Skill Education, CBSE, Integrated office, Sector 23 , Dwarka , New Delhi-110077 alongwith one page report about exposure visit within 10 days of conclusion of exposure visit.
- Bills submitted through email or WhatsApp will not be accepted or entertained under any circumstances.
