Professors from PSSCIVE/ NCERT or any University or Principals (Retired/In-service) or Retired Officials from KVS, NVS.**

The CBP will be conducted in offline (face-to-face) mode as per the details given below:

The Lead Facilitators will be conducting training Programmes for the identified **Master Trainers** (identified through the RO/CoE). Thereafter, these Master Trainers will conduct the Training of Teachers (ToT) in every RO/COE to ensure the mandatory implementation of Skill Education in classes VI-VIII, effectively.

Position	Retd. Professors from PSSCIVE/ NCERT or any University or Principals (Retired/In-service) or Retired Officials from KVS, NVS or Freelancer or Industry Trainers.
Teaching Experience	Min 10-15 years of teaching experience.
Subjects taught (Preferred)	Skill subjects/ Social Science/ Science/ Mathematics/ Computer Science/ Art related subjects.
Core Competencies	- Effective facilitation, mentoring, coaching, and communication skills - Ability to design and deliver experiential learning sessions
Training Experience (Preferred)	Demonstrated experience in conducting or facilitating in-person trainings/ workshops.
CBP Credentials	Minimum 100 hours of CBPs completed as applicable
Availability	Willingness and ability to travel across regions for conducting CBPs/ToT

- There is no fee for attending this Capacity Building Programme.
- No TA/DA will be admissible as per CBSE norms.
- Only the participants who fulfil the above-mentioned criteria and receive a confirmation email from CBSE shall be allowed to attend this CBP.**
