## **TERMS AND CONDITIONS**

- 1. The tenders duly filled in all respects should be dropped in Tender Box kept at reception CBSE, Preet Vihar, Delhi-110301 on or before **23.06.2014**latest by 3:00 PM along with requisite Tender Form fee of Rs. 500/- (Rupees five hundred only) and **Earnest Money Deposit** (EMD) of Rs.50,000/- (Rupees fifty thousand only) in the form of Bank Draft/Banker's Cheque **favoring** "Secretary, CBSE" payable at Delhi. No tender form without Bank Draft/Banker ChequeforTender Form fee and EMD will be entertained. The EMD of the unsuccessful bidder will be refunded without any interest.
- 2. Tenders will be opened on the same day at 3:30 P.M by a Committee constituted by the Competent Authority of Board in presence of the tenderers, who would like to be present at the time of opening of the tender. No separate communication will be sent in this regard.
- 3. Terms and conditions of the tender shall be read in conjunction with the General conditions of contract, bill of quantities & other documents being part of this contract.
- 4. The rates quoted will be valid for a period of one year and rate contract may be extended further for two year on year to year basis on the sole discretion of the Board, if services found to be satisfactory.
- 5. The **Vehicles must not be older than 03 (three) years** and should have a valid Registration Certificate along with other papers and comprehensive insurance during the period of contract. The agency should have a minimum experience of three years.
- 6. The rates should be both in words and figures and include all the taxes like Octroi, Road Tax, Toll-Tax, Service Tax, Fuel, Driver& helper's over-time and halting charges or Charges of any kind etc. The vehicle may also be used in Delhi Local &Delhi NCR and outside Delhiup to 1000-1200 KM distance from various office of CBSE, Delhi/Noida.Inter-state taxes shall be borne by tenderer.No extra charges/expenses occurring en-route on journey on repair of vehicle or any other matter will be borne by the Board.
- 7. The Parking charges onlybe borne by the Board subject to submission of original receipt (s) at the time final payment.
- 8. In case the price of petroleum/diesel products increases or decreases the rates offered will not be effected. **No escalation will be considered**.
- 9. Successful tenderer has to submit **Performance Guarantee amounting to Rs. 2.50 Lakh** (Rupees Two lakh fifty thousand only). The Earnest Money Deposit (EMD) of the successful bidder will be converted into Performance Guarantee and balance amount of Performance Guarantee shall have to be deposited within a week's time from the date of award of work in the form of Bank guarantee /FD from any nationalized Bank in favour of "Secretary, CBSE, Delhi".
