TERMS & CONDITIONS

- 1. The work shall be executed as per CPWD specifications and as per directions of Engineer-In-Charge.
- 2. All T & P shall be arranged by the Contractor.
- 3. The materials to be used must be got approved from the Engineer-in-charge before installation/use.
- 4. The agency will take all precautionary measures for safety of his workers during Performance of the work.
- 5. The work is to be completed within a period of 07 days after issue of the Work Order.
- 6. The work shall not be discontinued at any cost.
- 7. The agency shall get the samples of the material approved in advance before utilization.
- 8. The workmanship must be excellent. In case of poor workmanship, the Board shall be free to cancel the contract.
- 9. The work shall be executed under the strict supervision of the Board's Assistant Engineer.
- 10. In case of delay, a penalty @ 1% per week shall be levied subject to a max of 5%.
- 11. In case of poor workmanship, the Board shall have the right to rescind the contract and get the work executed through any other agency at the risk & cost of the defaulting contractor.
- 12. In case the work is kept suspended without any valid reason, the Board shall be free to get the remaining work executed through any other agency.
- 13. The contractor shall be required to provide adequate safety for its workers and the Board shall not be accountable to any kind of injury/ accident at site.
- 14. The agency shall be solely responsible for any damage/loss to the Board's Property/Equipment's.
- 15. TDS shall be deducted from the bill as per Govt. Rules.
